Tribute to Terry Whitby 20 December 1956 - 15 September 2009

At the time of his passing, Terry Whitby (*pictured on right*) was the President of the Executive Committee for the Aboriginal Legal Service of Western Australia (ALSWA).

He was voted into this role during 2008 and enthusiastically embraced his involvement and input into the service, which he referred to as an 'icon body'.

Terry always had a great commitment to social justice and first became involved with the ALS in its early days during the 1970's.

As one of the services pioneering Field Officers, he was greatly committed to striving for justice for Aboriginal people. He also played an important role during the years when the Court Officer Unit was being established, and this unit remains a vital part of the ALS over thirty years on. As a former staff member, and through his involvement with the Executive Committee, Terry has provided a wealth of experience and guidance to many people.

Through his role as President, he was deeply committed to prioritising areas such as prisoner reform, alcohol programs and family violence so that there would be more opportunities and better outcomes for Aboriginal people in the future.

Terry remained greatly supportive of the unique work done by the Court Officers and the role that the ALS played within the justice system. As our President and

friend he showed invaluable guidance and

commitment to his role. We are honoured that Terry's last years were spent working with us striving towards a more just and equitable justice system for our future generations.

H is k n o w l e d g e. involvement, humour, dedication, strength, inspiration and friendship will be sadly missed. Our thoughts are with all of Terry's family and friends, we share their loss.

And to you Terry, our brother and our friend, we say 'thank you'. We will always be inspired by your strength and courage as we continue striving for justice for our people.

Farewell Terry and rest peacefully – you will continue to inspire us our friend and brother, thank you for all you have done and for your compassion and commitment to our people.

ALSWA's role with FVPLS

This year saw ALSWA take on the auspicing role for WA Family Violence Prevention Legal Services (FVPLS). Katrina Carlisle, FVPLS Executive Officer (pictured on *left*) is confident that this development will have many benefits for families across WA. "One of the principle for ALSWA reasons undertaking an auspicing role with FVPLS' was a recognition by ALSWA of the importance of delivery service and to justice access for children and women, young persons who are victims of crime and that improvements could be made through ALSWA to such service delivery. This is a wonderful opportunity to build on and improve the services for families in our state" said Ms. Carlisle.

In that respect, ALSWA has a proud history, spanning more than 30 years, of providing legal assistance to the WA Aboriginal community. The day to day operations of FVPLS auspiced by ALSWA are entirely independent from the day to day operations of ALSWA. ALSWA has no involvement of any kind nor seeks to influence in any way the provision of legal services by FVPLS' to its clients. Also the FVPLS units

are completely stand alone to ALSWA and there is no sharing of office space etc.

Staff members from FVPLS offices in Perth, Broome, Carnarvon, Kununurra, Port Hedland, Geraldton and Kalgoorlie met recently in Perth.

The meeting was organised to improve communication / linkages with each of the FVPLS units, and to develop consistent policies and procedures for all of the auspiced units.

More Prisoner Support roles at ALSWA

More support is now available for prisoners and their families through ALSWA's Prisoner Support Officers (PSOs).

These positions were created this year and our PSO's work out of ALSWA's Perth Head Office.

The role of our PSOs is to reduce repeat offending by supporting Indigenous prisoners and their families.

Regular prison visits to adults and juveniles ensures that there is information and support available in many areas including:

- Prison procedures
 - Help with parole
- Filling in forms
- Referrals for legal assistance
- Help with prisoner transfers
- Crisis intervention
- Advice on Funeral Leave
- Visits
- Family Support
- Referral to outside agencies including counselling
- Liaison with external support agencies or service providers
- Advocacy within the prison.

ALSWA PSOs can also address any questions

Prisoners may have and advocate for clients in relation to sentence. management issues.

In metropolitan Perth visits to prisoners are weekly and in remote and regional areas the visits are at least once every 2 months.

Our PSOs also travel to country WA to assist offrenders in accessing restorative justice and other suitable programs and they can provide education about programs and encourage the development of community based initiatives.

INSPECTING PLACES OF CUSTODY Professor Neil Morgan Forum with Inspector of Custodial Services



Professor Neil Morgan (*pictured on right*) is the WA Inspector of Custodial Services and he was the invited guest at a forum recently facilitated and hosted by the Aboriginal Legal Service of Western Australia (ALSWA).

"Inspecting Places of Custody: Issues, Practices, OPCAT & The Ward Case" a 2 hour workshop held at ALSWA's Perth Head Office, attracted much interest from ALSWA staff and external agencies including the Deaths in Custody Watch Committee, Amnesty International and Legal Aid WA.

Elder Ben Taylor gave the Welcome to Country before MC Tammy Solonec, ALSWA Senior Policy Officer introduced Professor Morgan to participants.

Also speaking at this event was Joseph Wallam, Community Liaison Officer at the Office of the Inspector of Custodial Services. (OICS).

The seminar provided the ideal opportunity for participants to hear from the Inspector of Custodial Services about wide ranging issues and to have the opportunity to ask questions at the end of the session

Topics covered included The Ward case, Aboriginal imprisonment, Parol Review Board, overcrowding in prisons, monitoring standards and OPCAT, OICS and the proposed OICS extension of powers, the Coroner's recommendations from the Ward Inquest, places of detention relevant to OPCAT, and OPCAT implementation in Australia.

Jonathon Reid admitted as a lawyer



Jonathon Reid (above right) is pictured with ALSWA Family Law Senior Solicitor Simon MacDonald who moved his admission. Also attending the admission were Mary Chape (Family Law Unit Managing Solicitor), Garth Melvold and family members of Jonathon Congratulations to Jonathon Reid from ALSWA's Family Law Unit who was admitted as a Lawyer in October. A Yamaji/Burimaia man, Jonathon graduated from UWA (Bachelor of Law). His legal journey began in 1999 as an ALSWA Court Officer in Northam. This provided an invaluable insight into the issues facing our people as he travelled around the Wheatbelt towns of Merredin and Moora, listening to the stories of community members, before providing legal assistance. Returning to 2007 ALSWA in provided Jonathon with the opportunity to work for his people whilst also completing his studies. "Justice is an elusive concept, but

management of the 'system of justice' and providing for our clients was my overwhelming motivation. After being given the chance to advocate for people in the Court of Petty Sessions, I realised that to successfully advocate or run a trial I would have to complete a law degree" he said.

Jonathon became interested in law when he caught a glimpse of the daily operations of a Perth courtroom. Witnessing the large number of Aboriginal people in court on any given day, he pledged to assist his people through this process, as a lawyer. After graduating from UWA's Indigenous Preprogram, Law he returned to uni as a student mature age studving law.

"I hadn't attended an educational setting for about 13 years so I feel that I have faced a significant challenge and accomplished my goals". Jonathon is grateful to UWA's School of Indigenous Studies, lawyer Kim Farmer who first invited him into a courtroom and his family for their ongoing support. "My hope is that our vouth recognise the importance of an education that opens up greater opportunities in life and allows for their voice to be heard. They will be the 'changers' in our society - changing racial discrimination to the acceptance of others, anger to empowerment, poverty to opportunity and loss to gain. It is our next generations' time time to act, to sacrifice. to be the voice of our ancestors and to put yourself in the place where your voice is powerful and vour message is heard. I chose to be an activist for change in the law courts and I'm very proud of my achievements. By becoming a lawyer I now have the opportunity to assist my people in times where it is necessary because of the intricacies of the Law and the court process".

Human Rights Consultation

Throughout 2009 an important consultation occurred in Australia about human rights. The consultation asked us to consider three questions:

Which Human Rights and Responsibilities should be protected and promoted?

Are Human Rights sufficiently protected and promoted?

How could Australia better protect and promote Human Rights?

The consultation was taken seriously with more than 40,000 people participating and over 35,000 submissions received. The Consultation Committee also conducted round table discussions in over 70 locations across Australia.

Community Seminar

On 1 May 2009, ALSWA facilitated an Indigenous community forum at Derbarl Yerrigan Health Service in Perth to encourage Indigenous participation in the consultation.

ATSILS Joint Submission

ALSWA contributed to a joint submission, along with other Aboriginal and Torres Strait Islander Legal Services (ATSILS). Each ATSILS provided valuable insights into the human rights violations against our clients. In regards to whether or not to have a Human Rights Act, we said:

"ATSILS support the adoption of a Commonwealth Human Rights Act that is binding on all States and Territories. However, it is important to recognise that this model, as opposed to Constitutional reform, is vulnerable to the whims of successive governments such as the recent suspension of the Racial Discrimination Act (RDA) in the Northern Territory (NT) in order to enact the NT Emergency Response legislation (NTER). In the future, serious consideration needs to be given to constitutional reform. If a Human Rights Act is adopted, the Act should provide for a preamble or some other special acknowledgment of Aboriginal and Torres Strait Islander peoples as the First Nations peoples of Australia. In determining how this acknowledgement is worded and to ensure that the Act adequately protects Aboriginal and Torres Strait Islander people, Aboriginal and Strait Islander individuals Torres and organisations must be sufficiently consulted in ways that are culturally appropriate and accessible to the most disadvantaged and remote sections of the Aboriginal and Torres Strait Islander community."

Recommendations from the Consultation

The report from consultation was released on 8 October 2009, with 31 recommendations including that Australia should adopt a Federal Human Rights Act.

It was recommended that this Act outline rights and responsibilities and give individuals a cause of action which offers recourse and remedies where human rights have been violated.

Human Rights Consultation continued

The recommendations revolved around the following themes:

Creation of a human rights culture; Human rights in policy and legislation; Human rights in practice; Human rights and Indigenous Australians; and Human Rights Act.

Government Response

An interim Government response to the report was released in October 2009. That response said the Government is committed to addressing human rights in Australia and that the debate "is not about whether we protect human rights — it is about how we protect human rights."

The Government said they were committed to taking action to foster an Australian culture where the fundamental human rights of all people are respected and protected, and to ensure a range of mechanisms are available to promote and protect those rights. This is a positive response, but we will wait with anticipation to see what model is suggested and we along with other ATSILS will continue to provide comment and feedback into that process.

pleasing that a number of It was the recommendations referred specifically to our Eg: the first theme recommended people. specifically that "any education and awareness campaign incorporate the experiences of Indigenous Australians – with a particular focus on recent and historical examples of human rights concerns"; and that a readily comprehensible list of Australian rights and responsibilities be drafted that "acknowledge and respect the special place of our Indigenous people and acknowledge the need to redress their disadvantage."

The fourth theme "Human Rights and Indigenous Australians" is important to us. Recommendation 15 sought to deal with the suspension of the Racial Discrimination Act for 'Special Measures' as was done for the Northern Territory intervention. It recommended that if the RDA is to be suspended on such grounds again, then the Federal Parliament should be supplied with a "statement of impact on Aboriginal and Torres Strait Islander peoples". Recommendation 16 suggested that the Federal Government develop and implement a framework for selfdetermination for Indigenous peoples.

Whilst these recommendations are welcomed by ALSWA, we believe they do not go far enough in recognising and protecting the unique rights of Indigenous Australians.

Tammy Solonec achieves long term legal ambition

It was a proud occasion for Tammy Solonec and her children, family and friends when she was admitted as a lawyer in December last year.

Now a Senior Policy Officer with ALSWA, Tammy had wanted to study law from an early age.

"I have always been interested in politics and current affairs, which I think has something to do with the fact that my Dad watches hours of news every night and we were always discussing and debating things as I grew up.

During my teenage years, Mum went to Uni and did a degree in Aboriginal and Intercultural Studies at ECU. She explained to us the things she learnt and that, along with having been born in Derby and grown up in regional and remote WA (including Derby, Exmouth, Mullewa, Marble Bar and Tom Price) gave me a passion for Indigenous affairs and trying to address some of the gross inequities against Aboriginal people in this country.

When I was 16 Mum and I moved to Perth so I could complete my high school and she her degree. I did my TEE and did well but not enough to get into law, so I enrolled to become a Physed Teacher. Then, I found out about the inaugural Pre-Law Program at UWA and applied. This was when I was 17, in 1993.

I got in and then I did the 5 week intensive which got me into Law school.

The Pre-Law Program was set up by Richard Bartlett and Neil Morgan from the UWA law school, Martin Flynn from the NT Uni and Dr. Jill Milroy from the School of Indigenous Studies. The program was very successful and

went on to be mirrored in universities all across Australia and has lead to hundreds of Aboriginal people gaining law degrees. It has recently been awarded the prestigious Neville Bonner Award for Indigenous Education.

Getting admitted on the 19 December 2008 was really emotional because it took 14 years all up to become qualified..." (due to juggling study with other commitments) "...and I am so happy now to be doing what I have wanted to do for so long.

It was natural that I wanted to work at ALSWA. I am working in policy now, because I have managed to get a good understanding of legislation and government after working as a state public servant for over 5 years. My advice for other Aboriginal people embarking on a law degree is to be persistent, even when the going gets tough and to ask for help when you need it. I believe people who do well in law must be determined, organised and committed" said Tammy, who is a proud mother and currently holds the position of ALSWA's Senior Policy Officer.

ALSWA expands human rights work

ALSWA's philosophy is enshrined in the principles of international human rights law as set out in the Universal Declaration of Human Rights. These principles recognise the inherent dignity and the equal and inalienable rights of all people as the foundation for justice, which form the basis for the services ALSWA provides.

The Australian Government has indicated a new willingness to consider international human rights law for guidance in its treatment of Aboriginal people, (eg: its recent support of the Declaration on the Rights of Indigenous People)

Solicitor Seranie Gamble (pictured) has taken on a newly created role in ALSWA's Law and Advocacy Unit, specialising in international human rights law and advocacy. The role focuses on empowering Aboriginal people to better understand and realise our fundamental human rights, and to learn more about the international mechanisms, developments and achievements that relate to Aboriginal people internationally. This includes promoting the implementation of the Declaration of the Rights of Indigenous People, utilising the Special Rapporteur on the situation of human rights and fundamental freedoms of Indigenous Peoples, and seeking consultative status as a non-government organisation with the United Nations Economic and Social Council to facilitate our increased involvement with the United Nations Permanent Forum on Indigenous Issues and

the Expert Mechanism on the Rights of Indigenous People.

ALSWA has already co-hosted a community forum with the National Native Title Council for the Special Rapporteur during his visit in August 2009. Community members were invited to attend a round table session with the Special Rapporteur to voice their human rights concerns. The Special Rapporteur spent half a day listening to participants and assuring them their issues will be considered in his final report to the United Nations Human Rights Council. ALSWA the provided Special Rapporteur with copies of our most recent submissions and invited Managers to participate in the roundtable sessions to inform him of the concerns we have about the rights of Aboriginal people in WA.

We also delivered a workshop presentation at the National

Community Legal Centre Conference in Perth in September 2009 about the relevance of international human rights law to Aboriginal people and exploring how to use this workshop as a tool for reaching out to the community about these issues.

ALSWA is collaborating with the Australian Human Rights Commission, Curtin University, the South West Land and Sea Council and the Diplomacy Training Program to coordinate a series of Indigenous Human Rights Workshops in 2010.
