To all of our staff, your ongoing efforts are greatly appreciated. We look forward to the year ahead and continuing to provide our high standard of legal support and representation.



## STOP AND SEARCH – ALSWA calls for Bill to be withdrawn



ALSWA is concerned that WA's proposed 'Stop and Search' laws will lead to an increase in vulnerable people being targeted by police. ALSWA Executive Officer and Acting CEO John Bedford (*pictured on left*) believes that a further increase in police powers will see our most disadvantaged targeted. "Aboriginal people in this state are already over-policed and over-represented within the court and prison systems, and it is our people who will feel the impact" he said. ALSWA welcomes the concerns of others who have also spoken out against the laws

including the Equal Opportunity Commission, the Law Society, and former Superintendents Parkinson and Watson. In its submission to the *Criminal Investigation Amendment Bill 2009 (Stop and Search Laws) Inquiry*, ALSWA said 'the proposed laws will disproportionately impact on vulnerable groups and constitute serious violations of Australia's obligations under international human rights law'. ALSWA is also concerned about the impact that stop and search could have on those who feel aggrieved

at being singled out and searched by police for no reason. "These powers could lead to people feeling unfairly victimised and reacting in such a way that leads to a potentially volatile and escalating situation. When one considers this scenario in conjunction with the new mandatory sentencing laws for 'assaults on public officers causing injury', further human rights could be impinged upon and over-representation within prisons further exacerbated" said Mr. Bedford.

**ALSWA urges the Legislation Committee and government of WA to withdraw this Bill.**

### New Line up in Family Law Unit

ALSWA welcomes solicitor Neil Anderson who has joined the Family Law Unit. Neil replaces Simon MacDonald who moved interstate late last year after many years working in Family Law at ALSWA. Also farewelled (in February 2010) was Berni Lockyer who headed north to the Pilbara to work at the Roebourne Prison. Berni is widely known for her community work over many years and has spent the past 7 years with ALSWA in a variety of roles including Court Officer, Family Liaison Officer/Community Educator and Women's Contact Officer. ## PROFILE ON LES O'NEILL - FVPLS Accountant

Les O'Neill (*pictured on right*) is one of the few Aboriginal accountants in Western Australia and he has recently started work with the Family Violence Prevention Legal Service (FVPLS) in Perth (which has ALSWA as its Auspicing Body). Originally from the Shark Bay or Mulgana (Cutha Gooda) area, Les moved to Geraldton at a young age and stayed there for many years. “I still call myself Shark Bay mob though, as does anyone who comes from there, no matter how long they've been away. I worked with Centrelink in Joondalup for about six years, and being Salt water, I guess when Christine Anu sang that Warumpi band song (“*My Island Home*”), it kinda made me miss my family. Am older now, and so I guess I'm more comfortable with being able to move around”.

Becoming an accountant five years ago, Les started his career as one of only three cadets selected nationally to work with ATSIC in 2005. This opportunity paid for his Degree, plus a small wage and during semester breaks he would work with the field officers, reviewing the performance and financial activities of service providers in the region. Since graduating, he has worked with a local community organisation which provided accounting services to several Aboriginal Corporations in the Midwest Region, H&R Block Geraldton in Mainstream business audit, ITP Geraldton for a tax season, a Dongara Welding company as their accountant, RSM Bird Cameron, and coordinated TAFE's Accounting Lecturing.



“I think we need more Aboriginal Accountants. With qualified Indigenous accountants being so rare, most of the administrative and finance staff in Aboriginal organisations around the country are non-Indigenous. I'm really enjoy my work with FVPLS. It's a completely different area for me because we're basically trying to establish things from scratch” said Mr. O'Neill.

Apart from his career, Les says that family, stability and self-determination are also important. “I don't think we'll get anywhere as a people if we continue to rely on other people telling us what to do, and how to do it. That's what self determination means to me, that we determine our own fate and future, and we tell each other how to do that.

I wanted to work for FVPLS because it's a good opportunity for me to be around other Aboriginal professionals, who probably see things the same way as I do and the job also provides a chance for me to study on-campus for my MBA (*Master of Business Administration*)”. Les would love to see more Aboriginal people become accountants and looks forward to his future work with FVPLS.

## Diplomacy Training Program (DTP) held in Perth

The ‘*Indigenous Peoples Human Rights and Advocacy Training Program for Aboriginal and Torres Strait Islander Community Advocates*’ was held in Perth at UWA from 9-12 February. The program was run by DTP and Oxfam Australia in partnership with the Aboriginal Legal Service of WA and the Centre

for Aboriginal Studies at Curtin University. Around 30 participants gathered for this four day program, which aims to develop knowledge, confidence and skills of community advocates to effectively protect, promote and fulfil our rights, as recognised in international standards. ALSWA’s Law and Advocacy Unit Manager

Tammy Solonec said that the program was a wonderful opportunity for community representatives to get together and share their knowledge and skills and form important networks for future work. “ALSWA is very proud to have been involved in this important workshop”.
